

AUTHORIZATION TO USE IMAGE AND INTELLECTUAL PROPERTY RIGHTS

In consideration of the Consideration received, and by signing this Image Release Authorization, I grant the Assignees my permission to license and use the Content in any Medium and for any purpose (except for pornographic or defamatory purposes), including the marketing or promotion of any product or service. I further agree that the Content may be edited, combined with other images, text, graphics, films, audio and audiovisual works; altered by any means and in any form (authorizing the exploitation of the resulting content) and used to develop and improve machine learning algorithms, artificial intelligence and other technologies. I acknowledge that this authorization entails the use of the Content by the Assignees in activities involving costs and investments, the interruption of which would give rise to damages for which compensation would be owed.

I also expressly consent that the Content may be used as a basis for generating new visual representations of my likeness using artificial intelligence tools, as well as for training AI models or systems on the Content. I understand that such representations may be recognizable as my likeness and that their use will be subject to the same limitations set out in this Authorization, and may not be used for non-permitted purposes that could undermine my rights to honor, reputation and image.

Likewise, I consent that the Content may be transformed into audiovisual format or converted into any other form of exploitation, including through artificial intelligence tools, regardless of whether the result was captured during the Session or subsequently generated from the Content, provided that such transformation is not used for non-permitted purposes that could undermine my rights to honor, reputation and image.

I agree that Biometric Data derived from the Content may be used by the Assignees for the purposes mentioned above (except for the purpose of unique identification).

I hereby declare that the Rights Holders shall be the exclusive owners, worldwide and for the maximum legal term, of all intellectual property rights in the Content, including without limitation the rights of reproduction, distribution, adaptation, transformation and public communication, through any Medium, with the right to sublicense to third parties. I acknowledge and agree that, except to the extent required by applicable law: I have no rights in the Content; I am not entitled to any additional payment or other compensation; I will not make any further claims for any reason against the Assignees; and that this Image Release Authorization is binding upon my heirs and assignees. I agree that this Image Release Authorization is irrevocable, except to the extent that applicable law grants the Model a right to withdraw consent, including under applicable data protection legislation, worldwide and perpetual, to the extent consistent with applicable law, and is governed by the laws of Spain (excluding conflict of laws rules). I understand and accept that the scope of this assignment includes the substantial modification of the Content. In such case, I understand that any liability arising from any such modification shall rest solely with the Assignee carrying it out, to the exclusion of liability of all other Assignees.

I consent to the publication of my ethnicity and gender as voluntarily provided in this Image Release Authorization. Likewise, descriptive texts and keywords may be used in licenses, including Special Category Data. I also expressly consent that the Content may be transformed using artificial intelligence tools in a way that alters visible physical characteristics, provided that such transformation is not used for the purpose of biometric or singular identification of my person or used for non-permitted purposes that could undermine my rights to honor, reputation and image.

I understand and agree to this Image Release Authorization and that the information I provide here will not be made public unless otherwise agreed, but may be used in connection with the licensing of the Content when necessary (for example, to defend claims in court). The Content, including descriptive texts and keywords, will be made publicly available worldwide and may therefore be transferred to countries with potentially lower regulatory standards than Europe, under the terms set out in the privacy policy linked at the end.

I represent and warrant that I am at least 18 years of age and have full legal capacity to execute this Image Release Authorization.

Definitions. "Rights Holders" means the Photographer/Filmmaker and any other person or company to whom rights under this Image Release Authorization have been assigned or licensed, including their respective licensees and sub-licensees.
