

## AUTHORIZATION FOR ACCESS, CAPTURE AND USE OF IMAGES ON PRIVATE PROPERTY

Being the legal owner of or having the authority to permit the taking and use of photographs/videos and other still and/or moving images (in all formats) of that certain property described at the bottom of this document (the "Property") I hereby grant to the photographer and FREEPIK COMPANY S.L.U, a company of Spanish nationality, holder of Spanish Tax Identification number (NIF) B93183366 and registered address at C/ Molina Lario 13, 5th floor, 29015, Málaga, Spain, and its respective affiliates, subsidiaries, concessionaires, successors and assignees (collectively, the "Photographer"), the Photographer's successors and assigns, and those persons acting with the Photographer's authority and permission, the right to enter Owner's real property and to take and create photographs/videos and other still and/or moving images (in all formats) and other graphical depictions of the Property, in any and all media, whether now known or hereafter created (the "Content").

I hereby agree that all rights in and to the Content, including the copyright, are and shall remain the sole property of the Photographer, free and clear from any claims by me or anyone acting on my behalf.

Said Contents may be used by any mean or format and for any purpose, both by Photographer and by third parties to whom he transfers or licenses the Contents directly or indirectly, including without limitation campaigns, acts and promotional and advertising material, packaging of any product or service and any other use that could be given to said content. I expressly accept that the Contents can be combined with other images, text, graphics, films, audio files and audiovisual works and that they can be cut, altered or modified. I declare that I have been informed and accept the terms and conditions of use of Freepik's graphic resources.
